



TICKETING INFORMATION

TERMS & CONDITIONS OF ENTRY

The Territory Taste Festival is produced by Events Buro Pty Ltd (Event Producer). These below terms apply to the 2019 Territory Taste Festival, (Event) and staged at the Darwin Port Cruise Ship Terminal (Venue).

By purchasing or holding a ticket (you), you agree to these Terms. It is a condition of your ticket purchase for the event and a condition of entry to a Venue that you comply with these Terms.

NO RESALE AT PREMIUM

1. It is an essential condition of the right of admission to the Event conferred on the holder of a ticket that you and each subsequent holder of the ticket agrees not to (without Event Producer prior written consent):
 - a) resell or transfer, or attempt to resell or transfer, the ticket at a price greater than the face value of the ticket (including via on-line auction sites);
 - b) use it for advertising, promotion, competitions or commercial purposes; and
 - c) bundle it with other goods or services, such as food and beverage, accommodation or transport.
2. If this condition is breached, the event producer may deny the holder admission to the Event and retain the price of the ticket.

REFUSAL OF ENTRY

3. For the comfort, safety and enjoyment of all patrons, Event Producer and Venue management reserve the right to refuse entry to an Event:
 - a) if ticket is damaged, defaced, forged or copied or has not been purchased from an authorised ticket agent;
 - b) persons deemed to be intoxicated, under the influence of drugs or disorderly or the presence of the person would be detrimental to, or compromise safety at, the Event;
 - c) persons wearing or displaying commercial, political or other offensive signage or logos (except for official merchandise or other Event related clothing worn in good faith);
 - d) unauthorised persons or persons not in possession of a valid ticket or accreditation;
 - e) persons who refuse to be inspected or submit belongings for inspection;
 - f) of items which have the potential to cause injury or public nuisance, including Restricted and Prohibited Items; and
 - g) due to adverse weather, dangerous situations or any other causes that may affect the safety of patrons.

GENERAL CONDITIONS OF ENTRY

5. The following applies as a condition of entry into a Venue:
 - a) A ticket must be shown to gain entry to all paid events
 - b) Venue reserves the right to inspect and search bags brought into or out of Venue;
 - c) Persons 13 years and under must be under the direct supervision of a ticket holding parent or legal guardian at all times;
 - d) You must not enter any Venue's restricted areas, such as back of house, competition and performance areas, dressing rooms, VIP and hospitality areas or any other area not accessible by the public;
 - e) Pass-outs will be issued at the discretion of the Event Producer;

- f) Narcotics (other than those prescribed by a registered medical practitioner) must not be taken into or out of the Venue;
 - g) Alcoholic beverages must not be taken into or out of the Venue. It is an offence for minors to purchase or consume alcohol or for persons to supply alcohol to minors. Alcohol may only be consumed in clearly marked areas of the Venue;
 - h) Patrons are not permitted to bring food or beverage into the Venue. Consideration will be given to those with special dietary requirements;
 - i) Smoking (including the use of electronic cigarettes or similar devices) is prohibited;
 - j) No umbrellas or shade structures may be brought into the Venue;
 - k) Unauthorised soliciting, collections and customer surveying is not permitted
6. You must not engage in any form of ambush marketing and must not conduct any activity that conflicts with, impairs, infringes or denigrates the rights of any official sponsor or the Event Producer.

EVICTION FROM VENUE

7. The Event Producer or the Venue reserves the right to eject from a Venue without refund any patron who:
- a) breaches any General Condition of Entry;
 - b) does not produce a valid ticket on request;
 - c) is in breach of any of these Terms;
 - d) may unreasonably obstruct the viewing of other patrons;
 - e) may be a source of danger, nuisance, or annoyance or otherwise give rise to concerns in relation to the safety and security arrangements for an Event, including excessive noise, use of foul, obscene, abusive or racist language or gestures, the wearing or other display of commercial, political or offensive signage or logos, or the throwing of any object that might injure or cause damage to people or property;
 - f) fails to comply with instructions from a police or security officer;
 - g) is in possession of any item listed on the Restricted and Prohibited list;
 - h) is suspected of committing, or being likely to commit, or having committed a criminal offence within the Venue;
 - i) enters any area at the Venue which he/she may be prohibited to enter;
 - j) damages, interferes with or tampers with any Event Producer or Venue property; or
 - k) refuses to comply with requests made by Venue or event Producer staff.

RESTRICTED AND PROHIBITED ITEMS

8. The following restricted and prohibited items are not permitted into a Venue:
- Glass or cans
 - Illegal substances, including controlled, dangerous or illicit drugs
 - Weapons, or resemblance of weapons, including knives, firearms, blunt offensive objects, batons and those with sharp ends
 - Political or offensive materials
 - Recording devices (for commercial purposes) and tripods
 - Selfie sticks
 - Animals (other than trained assistance dogs)

9. Flyers, advertising, discounts, vouchers, signage or sampling products from people/businesses NOT exhibiting at the event is illegal and strictly prohibited. If material is found within the event site that has been distributed without purchasing a retail stall you will be followed up and charged a stall fee of \$2,500 by Territory Taste Festival event management.
10. You must comply with the directions or announcements from Event Producer or Venue staff and any other requirements relating to access and safety given by Event Producer or Venue staff or authorities.
11. You must maintain safe, prudent and respectful behaviour at all times. A patron is responsible for his or her own conduct whilst in a Venue for an Event and must pay for the cost of repair of any damage caused to a Venue as a result of their conduct.
12. You must not enter the competition or designated performance areas of a Venue at any time and, if you do, you may be fined, expelled from that Venue and subject to legal action.

LIABILITY AND RISK

13. Patrons wishing to bring personal items into Venue do so at their own risk. The Event Producer or Venue will not be held responsible for any damage to, loss or theft of, your personal property.
14. The Event Producer does not guarantee that you will have an uninterrupted and/or uninhibited view of a presentation from your location within the venue, nor does the Event Producer give any warranty as to the quality, content or duration of a presentation
15. Patrons attending the Event do so at their own risk, and assume all risk and liability for personal injury or death, including that of any minors under their care. The Event Producer bears no liability for any personal injuries, health problems or death sustained at or after an Event, including directly or indirectly resulting from any existing medical condition.
16. As this is a Festival of Food and Drink, there will be instances where food items or beverages will be shared or offered to audience members. While every effort will be made to communicate the ingredients of these items before sharing, the Event Producer cannot take responsibility for those with allergies or intolerances, and we cannot accommodate other dietary requirements, except in instances where we have requested this information in advance.

For Special Events, the Event Producer will request dietary requirements of audience members in advance, and every attempt will be made to meet these - however due to ingredient limitations and menu plans, this may not always be possible.

17. If Event Producer is liable to you for any breach of these terms (including negligence but not including fraud), the Event Producer's liability to you is limited to Event Producer repaying any amounts paid by you or supplying or resupplying any tickets to which you are entitled.

PHOTOGRAPHS AND BROADCASTS

18. Cameras (including digital cameras), audio and video recorders may be brought into a Venue only at the discretion of Event Producer.
19. Photographs taken within a Venue may be used only for private non-commercial purposes. For the avoidance of doubt, commercial purposes include licensing, merchandising, memorabilia, or marketing.
20. Patrons are not permitted to transmit, broadcast, sell, license or otherwise publish, disseminate or reproduce any recordings (including photographic, video or sound recordings) of the event without Event Producer's prior written approval.
21. If you make, reproduce or use any recording, data or image prohibited under this condition, you must assign in writing all copyright and intellectual property rights to Event Producer or its nominee.



TICKETING INFORMATION

22. You may be photographed individually or in a crowd scene and/or your voice recorded at an Event, with or without your knowledge. You irrevocably and unconditionally consent without compensation to the recording, transmission and use of your likeness and/or voice by any means (including, audio and visual recordings by television cameras and photographers) throughout the world, to the fullest extent possible in perpetuity, by Event Producer and its nominees.

EVENT CHANGES AND CANCELLATION

23. The festival program is subject to change without notice.
24. The Event Producer may add, withdraw, reschedule or substitute chefs, presenters and entertainers (as applicable) or vary advertised programmes, prices, times, venues, seating arrangement or audience capacity without any compensation to you.
25. The Event Producer may postpone, cancel, interrupt or stop an Event, or deny access to a Venue, due to adverse weather, dangerous situations or any other causes without any compensation to you.
26. The Event Producer is not liable to you for any loss or damage you suffer as a result any Event being cancelled, postponed or changed. The Event Producer disclaims the existence of any common law duty of care to you.
27. No refund or exchange of tickets will be made under any circumstances, except at an Event's discretion if that Event is postponed or canceled, and then according to that Event's refund and exchange policy.

PRIVACY STATEMENT

28. The Event Producer respects the privacy of the individuals on whom the Event Producer collects, uses and discloses personal information. The personal information that the event producer collects is used for the purpose of the sale and distribution of your tickets, as reasonably required for the proper and efficient staging of the Event and to give effect to any of its rights under these Terms.
29. You may request access to personal information the Event Producer holds about you by sending an email to events@territorytastefestival.com.au.

GENERAL

30. The Event Producer will not replace your ticket, if lost, stolen, forgotten, damaged, forged or unreadable.
31. The Event Producer may choose not to enforce a term of these Terms in some cases in its absolute discretion without affecting its right to enforce that term in other cases, including by replacing tickets (except forged tickets) if you can demonstrate proof of purchase and identity acceptable to the Event Producer.
32. If you are under 18 years of age, you may use the Event ticketing websites and purchase tickets only with the supervision of a parent, guardian or other adult person.
33. These Terms are governed by the law applicable in the Northern Territory and each party irrevocably and unconditionally submits to the exclusive jurisdiction of the courts of Northern Territory.

AMENDMENTS

34. The Event Producer reserves the right to update, modify or change these Terms from time to time. Any changes will be available on Event's website.
